The 4E Mapping and Benchmarking Annex: What is it and what is it trying to do?

The coming decade will see the establishment of substantive sustainable product policies affecting all major appliances, and many commercial products in most, if not all, trading zones of the world.

Unfortunately, the policy-makers charged with the development and implementation of these sustainable product strategies have difficulty identifying the potential performance of products already in, or soon to be available in, the global marketplace; the likely impact various policy options may have on these products; and how any resultant outcomes will compare with the actions taken and outcomes achieved elsewhere. Hence, these policymakers are often forced to make decisions with major environmental and economic impacts based on fragmented and incomplete data.

The countries participating in the IEA Implementing Agreement for a Co-operative Programme on Efficient Electrical End-use Equipment (Australia, Austria, Canada, Denmark, France, Korea, the Netherlands, Switzerland, the UK and the USA - see www.iea-4e.org) have identified this knowledge shortfall and have initiated this new Annex as a first step to developing credible, reliable and timely information for sustainable product policy-making decisions. This collaborative action, the 4E Mapping and Benchmarking Annex, seeks to address not just one, but a wide range of domestic, commercial and industrial products and seeks to provide:




Figure 1: Demonstration of summary mapping outputs

 Mapping of energy efficiency performance of electrical products in specific countries/regions. Where possible, the overviews will be presented as complete time series showing evolving product efficiency over time. Figure 1 below shows an example of potential outputs for an individual country.




Figure 2: Demonstration of summary benchmarking outputs

 Benchmarking of the product efficiency within individual countries/regions against others. Figure 2 opposite shows an example of the potential benchmarking of three countries and two regions against the best available technology (BAT) worldwide and the performance of the best products expected in the market in the near future (best not yet available technology - BNAT).

Outputs will also seek to identify the most effective policies for given product groups and the energy - and emissions - saving potentials for improvements in the individual, regional and global market.

- AC motors
- Computer displays
- Domestic air conditioners
- Domestic cold appliances
- Domestic laundry appliances
- Domestic lighting
- Integrated home networks
- Laptop computers
- Televisions
- Water heaters
